F. EXPENSE FUNDS:

In the event that expense funds are needed for an operation, the O.I.C. of the particular surveillance operation should obtain the funds through established procedures.

G. ESTABLISHING MEANS OF COMMUNICATION:

The O.I.C. of the surveillance operation should ensure that all officers are aware of appropriate call signs to be used in the operation and the proper radio channel to be utilized for routine operation. He should also ensure that the necessary communications equipment is obtained and is in good working order.
